Upon a petition for amendment of bargaining unit duly filed pursuant to Iowa Code section 20.13 and PERB rule 621-4.6(20), the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.

IT IS THEREFORE ORDERED that the bargaining unit of employees of Hamilton County initially determined in PERB Case No. 7163, and the certification of Chauffeurs, Teamsters and Helpers, Local Union No. 238, are amended to provide:

INCLUDED: All regular full-time deputy sheriffs, dispatchers and jailers.

EXCLUDED: Sheriff, Chief Deputy, Jail Administrator, Jail Supervisors, Office Manager, Dispatcher Supervisor, clerical employees, part-time employees, and all other employees excluded by Iowa Code section 20.4.

ORDER OF CERTIFICATION

IT IS THEREFORE ORDERED that Chauffeurs, Teamsters and Helpers, Local Union No 238 is hereby designated and certified as the exclusive bargaining representative of the following bargaining unit of employees of Hamilton County

EXCLUDED Sheriff, Chief Deputy, Jail Administrator, Jail Supervisors, Office Manager, Dispatcher Supervisor, part-time employees, and all other employees excluded by Iowa Code section 20 4.
