IT IS HEREBY ORDERED that Hancock County Secondary Road Workers should be, and hereby is, designated and certified by this Board to be the exclusive bargaining representative for the employees of Hancock County a public employer, in the following bargaining unit:

- INCLUDED Hancock County Secondary Roads Maintenance Employees (Maintenance Man I, Maintenance Man II, and Maintenance Man III) with Maintenance Man I as the entry level and Maintenance III being the highest level, 1st Mechanic, 2nd Mechanic (with 1st Mechanic being the higher level), Maintenance Foreman and Shop Foreman
EXCLUDED Engineer, Assistants to Engineer, Secretary to Engineer, Engineering Inspectors, Engineering Technician and all other persons excluded by Section 4 of the Act
