
IT IS HEREBY ORDERED that the bargaining unit previously determined in Case No. 3202 and the certification of 3202 is amended to read as follows:

INCLUDED: Employees of the Johnson County Board of Supervisors, Recorder, Treasurer, Auditor, Attorney, and the county's Data Processing, Physical Plant, and Planning and Zoning Departments; and employees of the Johnson County Department of Public Health in these existing classifications: Receptionist, Secretary I, Clerk I, Clerk II, Clerk IV and Social Work Associate.

EXCLUDED: All supervisory, confidential and other employees excluded by Chapter 20 of the Iowa Code, and other employees of the Johnson County Department of Public Health.

IT IS HEREBY ORDERED that PPME/IBPAT Local 2003 should be, and hereby is, designated and certified by this Board to be the exclusive bargaining representative for employees of Johnson County, a public employer, in the following bargaining unit:

INCLUDED: All employees in the offices of board of supervisors, recorder, treasurer, auditor, data processing, county attorney (including county attorney staff in the Child Support Recovery Unit, Cedar Rapids, Iowa), physical plant, zoning, and planning, in the job classifications of clerk, clerk II, clerk III, auto clerk, clerk typist, clerk typist II, clerk typist III, account clerk, word processor I, word processor II, secretary I, secretary, child support recovery aide, legal assistant, victim/witness coordinator, computer operator, program analyst, nonsupervisory deputy, custodian, and maintenance person.

EXCLUDED: Confidential and supervisory employees and all other excluded by Section 20.4, the Code.
