**AMENDMENT OF CERTIFICATION**



AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

Upon a petition for amendment of bargaining unit duly filed pursuant to Iowa Code section 20 15 and PERB rule 621-4 6(20), the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.

IT IS THEREFORE ordered that the bargaining unit initially determined in PERB Case No 1288, and the certification of Over the Road and City Transfer Drivers, Local Union No 147, is amended to read as follows:

INCLUDED All White Collar and Blue Collar Employees of Wapello County working in the Treasurer's office, the Auditor's office, the Recorder's office, the Attorney's office and the CPC office

EXCLUDED Elected Officials, Deputies, Chief Executive Officers, Supervisors, Confidential employees and others excluded by the Act
