ORDER OF CERTIFICATION

Upon a petition duly filed in accordance with Iowa Code section 20 14 and PERB rule, a representative certification election was conducted herein under the direction and supervision of the Board. The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the valid ballots were cast in favor of the affected bargaining unit's representation by Teamsters Local 147 61, that no objections to the election were filed as provided for in Iowa Code section 20 15 and PERB rule, and that the employee organization has complied with the relevant requirements of Iowa Code section 20 25

IT IS THEREFORE ORDERED that Teamsters Local 147 is hereby designated and certified as the exclusive bargaining representative of the following bargaining unit of employees of the Humboldt County Conference Board

INCLUDED All regular full-time and regular part-time jailers and cooks employed by the Webster County Sheriff's Office

EXCLUDED Supervisory employees, lead correctional officer, confidential employees, deputy sheriffs and all other employees of the Webster County Sheriff's Office, and all others excluded by Iowa Code section 20 4
