DECISION AND ORDER

Upon petitions filed under Sections 13 and 14 of the Public Employment Relations Act, a hearing was held before the Public Employment Relations Board (hereinafter referred to as Board), Members Cook and Loihl, on June 17, 1975. The Employer appeared by William E. Adams; Communications Workers of America appeared by Ron Nielsen; and Woodbury County, Iowa Deputy Sheriffs Association appeared by William A. Shuminsky. All parties had full opportunity to present evidence.

STATEMENT OF THE CASE

On February 26, 1975 the Petitioner, Woodbury County, petitioned for a unit of all county employees whose salaries are set by the board of supervisors. On March 27, 1975, the Communications Workers of America petitioned for a unit of heavy equipment operators, mechanics and drivers, referred to as a secondary roads unit during the hearing. On April 11, 1975, the Woodbury County, Iowa Deputy Sheriff's Association

separate unit in other jurisdictions. Black Hawk County,
PERB Case No. 10, April 3, 1975. For those reasons, the Board
finds that the secondary road employees constitute a separate
unit appropriate for the purposes of collective bargaining.

With the exception of the list of employees and general job categories submitted by the employer after the hearing, no evidence was presented concerning the remaining county employees. The Board does not believe, however, that it would be appropriate to combine in a single unit employees with such diverse classifications as laborers, secretaries, and psychological social workers. Hence, the Board determines that these employees should be grouped occupationally into three bargaining units: a unit of general office and clerical employees, a unit of all professional employees, and a unit of all laborers, domestic help, and other "blue collar" employees in the county. Black Hawk County PERB Cases No. 48 and 57.

In view of the foregoing, the Board finds that the following units are appropriate for purposes of collective bargaining:

- All deputy sheriffs, first, second third and fourth class, including the deputy clerk matron; but excluding the sheriff, supervisory sheriff's deputies, and all other employees of Woodbury County and those employees excluded by Section 4 of the Act.
- 2. All employees of the Secondary Roads Department; but excluding the county engineer, roads supervisor, foremen and chief surveyor, and all other employees of Woodbury County and those excluded by Section 4 of the Act.
- 3. All laborers, domestic help of Woodbury County; but excluding all employees of the Secondary Roads Department, other employees of Woodbury County, and those employees excluded by Section 4 of the Act.
- All secretarial, clerical and general office employees of Woodbury County, including nonsupervisory deputies;
