EXCLUDED: Auxiliary police officers and all other employees of the City of Bettendorf, I D technicians, animal control officers, crossing guards, clerical employees, and supervisors of the Bettendorf Police Department and other persons excluded by Section 4 of the Act (Chief of Police, Captains, and Lieutenant)
