ORDER OF CERTIFICATION


NOW on this 15th day of December, 1975, the Board being advised that an election was conducted pursuant to Order of the Board, and that Burlington Policemen's Association, Blackhawk Unit #3, an employee organization, received an affirmative vote of the majority of employees in the bargaining unit, and the Board having further found that the employee organization has fully complied with all regulations of the Act and the rules and regulations thereunder,

IT IS HEREBY ORDERED BY THE BOARD that Burlington Policemen's Association, Blackhawk Unit #3 should be, and hereby is, designated and certified by this Board to be the exclusive bargaining representative for the employees of City of Burlington, a public employer, in the following bargaining unit:

INCLUDED: All police officers and the police matron in the City of Burlington, including the police inspector, all captains and lieutenants, all detectives and patrolmen and the police matron

EXCLUDED The chief of police and the assistant police chief
