In early 2006, the CEO and Employer each filed AU petitions (7235 and 7244) which were consolidated for hearing. The ALJ agreed with each of the petitioners in part, and proposed an amended unit. Case 7235 was appealed to Board, but 7244 was not, and that change became final. The change wrought by 7244 was never reflected in a separate unit description, however, because the 7244 change was combined with the 7235 change in the ALJ's proposed decision.

Ultimately, the petition in 7235 was withdrawn. Consequently, the unit described in the proposed D & O never became the unit because it included changes wrought by 7235 which never became effective. For historical purposes, the file should reflect that, giving effect to the proposed D&O in 7244, which became final, without the proposed changes due to 7235, which did not, the unit as amended by 7244 only, which became final 4/27/06, is described as:

INCLUDED: All employees of the City of Cedar Falls employed in its Fire Department including those in the classifications of Firefighter, Lieutenant and Minimum Rental Housing Inspector.

DECISION ON APPEAL

This case is before the Public Employment Relations Board (PERB or Board) on appeal from a proposed decision and order of an administrative law judge in an amendment of bargaining unit proceeding filed by the Cedar Falls Firefighters Association, Local 1366 (the Association). The Association's petition sought to amend the unit's description to reflect the inclusion of the job classification of "Captain" as well as the new classifications of "Division Commander" and "Station Commander," and to eliminate any reference to the obsolete classification of "Fire Safety Officer."

At hearing before the ALJ, the Association withdrew the portions of the petition relating to the by-then-obsolete classification of Captain and the classification of Division Commander, and the parties stipulated that the Division Commander classification should be specifically excluded from the bargaining unit and that the description should no longer refer to a Fire Safety Officer in any way. Following the submission of briefs, the ALJ concluded that Station Commanders were supervisory employees within the meaning of Iowa Code

section 20.4(2) and thus proposed that the unit's description be amended to specifically exclude them.

Pursuant to PERB subrule 621-9.2(3), we have heard the case upon the record submitted before the ALJ during an evidentiary hearing on August 31, 2004. Oral arguments to the Board on appeal were heard on March 3, 2005, and both parties filed briefs on appeal. Pursuant to Iowa Code section 17A.15(3), on this appeal we possess all powers which we would have possessed had we elected, pursuant to PERB rule 621-2.1, to preside at the evidentiary hearing in place of the ALJ.

Based upon the entire record in this matter, and having considered the parties' oral arguments and briefs, we conclude that the Station Commanders, with the exception of one who serves as the Fire Department's Training Coordinator, are supervisory employees excluded from the coverage of Iowa Code chapter 20, and issue the following:

FINDINGS OF FACT

The City of Cedar Falls is a public employer within the meaning of Iowa Code section 20.3(11) and the Association is an employee organization within the meaning of section 20.3(4).

The Association was certified as the exclusive bargaining representative for certain employees in the City's Fire Department on December 8, 1975. The unit was amended in 1977, 1982 and 1997, and as of the date of hearing was described as:

INCLUDED: All employees of the Cedar Falls Fire Division including firefighters, lieutenants, and Minimum Rental Housing Inspector.

viewed as unusually top-heavy. However, our unit determinations must be made on the basis of our application of Iowa Code sections 20.4 and 20.13.

We conclude that the Station Commanders, with the exception of one who serves as the Fire Department's Training Coordinator, are supervisory employees excluded from the coverage of Iowa Code chapter 20. Accordingly, IT IS HEREBY ORDERED that the bargaining unit most recently amended in PERB Case No. 5683 is amended to provide:

INCLUDED: All employees of the City of Cedar Falls employed in its Fire Department including those in the classifications of Firefighter, Lieutenant, Training Coordinator Station Commander and Minimum Rental Housing Inspector.

EXCLUDED: Fire Chief, Division Commanders, Shift Station Commanders, Secretary and all others excluded by Iowa Code section 20.4.
