Upon a petition for amendment of bargaining unit duly filed pursuant to Iowa Code section 20.13 and PERB rule 621-4.6(20), the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules. One objection to the proposed decision was filed within the time specified in the public notice, but was withdrawn prior to hearing.

IT IS THEREFORE ORDERED that the bargaining unit initially determined in PERB Case No. 342 and amended in Case Nos. 791, 3916, and 6377, and the certification of Chauffeurs, Teamsters & Helpers, Local 238, is amended to provide:

INCLUDED: Sergeants, Police Officers, Police Officer/Firefighter, Part-time Police Officer, Senior Police Officers, Parking Meter Attendants, Computer Operators, Records & Computer Services Supervisor, Dispatchers (full-time and part-time), Clerical/Office Assistants (full-time and part-time), and Crossing Guards.

EXCLUDED: Police Chief, Captains, Lieutenants, Administrative Secretary, Investigative Unit Specialist, all other City employees and all those excluded by Iowa Code section 20.4.





ORDER OF CERTIFICATION

NOW on this 6th day of January, 1975, the Board being advised that an election was conducted pursuant to Order of the Board, and that Over the Road and City Cartage Drivers, Local No. 844, an employee organization, received an affirmative vote of the majority of employees in the bargaining unit, and the Board having further found that the employee organization has fully complied with all regulations of the Act and the rules and regulations thereunder,

IT IS HEREBY ORDERED BY THE BOARD that Over the Road and City Cartage Drivers, Local No. 844, should be, and hereby is, designated and certified by this Board to be the exclusive bargaining representative for the employees of City of Cedar Falls, a public employer, in the following bargaining unit:

INCLUDED: Sergeants, patrolmen, police investigators, assistant police shift, supervisors, parkettes (meter maids), radio dispatchers, switchboard operator, crossing guards, co-op workers, secretary I, full-time and part-time clerical, captains of the records, training, and traffic units, lieutenants of the investigative unit.

EXCLUDED: Police chief, assistant police chiefs, shift supervisor lieutenants, swing shift captain, administrative assistant captain, secretary II, all other city employees and all those excluded by Section 4 of the Act.
