ORDER OF CONTINUED CERTIFICATION

Following the filing of a valid representative decertification petition pursuant to Iowa Code section 20.15(6) and PERB rule, a decertification election was conducted herein under the direction and supervision of the Board. The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the valid votes were not cast in favor of the decertification of AFSCME/Iowa Council 61 as the exclusive bargaining representative of the bargaining unit described below.

No objections to the election having been filed as provided for in Iowa Code section 20.15(4) and PERB rule, the Board finds that an order of continued certification should be issued.

IT IS THEREFORE ORDERED that AFSCME/Iowa Council 61 remains the exclusive bargaining representative of the following bargaining unit of employees of the City of Glenwood:

INCLUDED: Police Officer I, II, III; Street Crewman I, II, III, and Police Sergeants in the City of Glenwood, Iowa.

EXCLUDED: Public Works Director, Street Crewman Supervisor, City Administrator/Financial Officer, City Clerks, Code Enforcement Officer, Police Chief, Police Captain, Police Lieutenant, Elected Officials, Police Secretary, and Cemetery Sexton and all other Employees excluded by Iowa Code section 20.4.

Upon a petition for amendment of bargaining unit duly filed pursuant to Iowa Code section 20.13 and PERB rule 621-4.6(20), the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.

IT IS THEREFORE ORDERED that the bargaining unit of employees of the City of Glenwood initially determined in PERB Case No. 5726, and the certification of AFSCME/Iowa Council 61, are amended to provide:

INCLUDED: Police Officer I, II, III; Street Crewman I, II, III, and Police Sergeants in the City of Glenwood, Iowa.

EXCLUDED: Public Works Director, Street Crewman Supervisor, City Administrator/Financial Officer, City Clerks, Code Enforcement Officer, Police Chief, Police Captain, Police Lieutenant, Elected Officials, Police Secretary, and Cemetery Sexton and all other Employees excluded by Iowa Code section 20.4.
