AMENDMENT OF CERTIFICATION



ORDER OF CERTIFICATION

NOW, on this 30th day of July, 1984, the Board being advised that an election was conducted pursuant to Order of the Board, and that a majority of the ballots were cast for Over the Road, City Transfer Drivers, Helpers, Dockmen, Warehousemen, Inside Workers, State, County & Municipal Employees, Teamsters Local 147, an employee organization, and the Board being further advised that said employee organization has complied with all requirements of the Act and the Rules and Regulations thereunder,

IT IS HEREBY ORDERED that Over the Road, City Transfer Drivers, Helpers, Dockmen, Warehousemen, Inside Workers, State, County & Municipal Employees, Teamsters Local 147, should be, and hereby is, designated and certified by this Board to be the exclusive bargaining representative for the employees of City of Humboldt, a public employer, in the following bargaining unit:

INCLUDED All police officers employed at the Employer's facility in Humboldt, Iowa.

EXCLUDED Chief of Police, Assistant Chief, members of police auxiliary unit, and all others excluded by the Act.
