IT IS THEREFORE ORDERED that the bargaining unit previously determined in Case No 699 and amended in Case No 1267, and the certification of Municipal Laborers Union, Local #353, is amended to read as follows:



EXCLUDED: City Treasurer, City Attorney, City Clerk and Deputy City Clerk, computer analyst, service Director, chief city inspector, street department superintendent, sewer-water pollution control superintendent, personnel and payroll clerk, fire department, all employees of the Indianola Water Works and Electric Light and Power Board of

Trustees, Park and Recreation Director, Park Superintendent, Recreation Superintendent, Library Board employees, Police Sergeant, Assistant Police Chief, Police Chief, and all employees excluded by Section 4 of the Act

EXCLUDED City Treasurer, City Attorney, City Clerk and Deputy City Clerk, computer analyst, service director, chief city inspector, street department superintendent, sewer-water pollution control superintendent, personnel and payroll clerk, all employees of the police department, fire department, all employees of the Indianola Water Works and Electric Light & Power Board of Trustees, Recreation Commission, Park Board, Library Board employees, and all employees excluded by Section 4 of the Act
