AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

Upon a petition for amendment of bargaining unit duly filed under Iowa Code section 20 13 and Public Employment Relations Board rule 621-4 6(20), an evidentiary hearing was conducted by a Board-appointed administrative law judge, who subsequently issued a proposed decision pursuant to Iowa Code section 17A 15(2) The ALJ proposed that four of the five job classifications at issue be excluded from the bargaining unit, but proposed that the classification of "recreation program supervisor" continue to be included within the unit

On an intra-agency appeal from the proposed decision, in which only the ALJ's conclusion concerning the recreation program supervisor classification was challenged, the Board concurred that the classification was properly included within the AFSCME Local #183-represented bargaining unit, and that the bargaining unit should thus be amended as proposed by the ALJ

IT IS THEREFORE ORDERED that the bargaining unit initially determined in PERB Case No 544 and amended in PERB Case Nos

2872, 2972 and 3829, and the certification of the American Federation of State, County and Municipal Employees, Local #183, is amended to provide as follows

INCLUDED All City of Iowa City employees, including recreation program supervisors

EXCLUDED Customer service manager, Library employees, sworn Police and Fire employees, public housing coordinator, section 8 coordinator, senior maintenance worker (recreation), senior maintenance worker (cemetery), supervisory and confidential employees, and any others excluded by Iowa Code section 20 4
