

INCLUDED All full time and regular part time employees of the City of Iowa Falls, Iowa, employed in the Water Department, Sanitation Department, Street Department and Mechanic's Department.

EXCLUDED Members of the Police Department, employees of the Administration Department, Finance Department, Electrical Department, Building Department, Parks Department, Waste Water Department, Library, Volunteer Fire Department, all elected officials, all clerical employees, Supervisors including. Foreman Sanitation Department, Street Superintendent, Water Superintendent, Head Mechanic and all others excluded by Section 4 of the Act.
