AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

Upon a petition for amendment of bargaining unit duly filed pursuant to Iowa Code section 20.15 and PERB rule 621-4.6(20), the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation, contingent upon the conduct of a representative certification election among the employees to be added to the unit, was posted in conformance with PERB's rules. No objections to the proposed decision were filed.

The representative certification election having been conducted among the employees proposed for addition to the unit, and a majority of the valid votes having been cast in favor of their representation by the certified employee organization, the Board finds that an order amending the bargaining unit should be entered.

IT IS THEREFORE ordered that the bargaining unit of employees of the City of Jefferson initially determined in PERB Case No. 4075, and the certification of AFSCME/Iowa Council 61, is amended to provide:

INCLUDED: Employees of the City of Jefferson in the Police Department, Sanitation Department, Street Department, Water Department, Wastewater Department, Parks and Cemetery Department and City Hall.

EXCLUDED: Chief of Police, Police Captain, Parks and Recreation Director, Superintendent of Wastewater, Superintendent of Streets, Superintendent of Water, City Clerk, Deputy City Clerk, and all others excluded by Iowa Code section 20.4.


