AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

Upon a petition for amendment of bargaining unit duly filed under Section 13 of the Public Employment Relations Act [Act], Chapter 20, Code of Iowa (1989) and Rule 4.6 of the Public Employment Relations Board [Board or PERB], the parties filed with the Board a Stipulation of Bargaining Unit.

Said Stipulation has been tentatively approved by the Board; a Public Notice of Proposed Decision of Amendment of Bargaining Unit has been posted in conformance with PERB Rules; and no objections have been filed, therefore:


IT IS HEREBY ORDERED that the bargaining unit previously determined in Case No. 3003 and amended in Case No. 3116, and the certification of Teamster #238, is amended to read as follows:

INCLUDED: All full-time and part-time employees employed by the employer including Police and Public Works Department (Street, parks and water).

EXCLUDED: All elected officials, Chief of Police, Superintendent of Public Works, Contracted Waste Water Operator, confidential secretary and others as defined by Public Employment Relations Act.
