Upon a joint petition for amendment of bargaining unit duly filed pursuant to Iowa Code section 20.13 and PERB rule 621-4 6(20), the parties agreed to a bargaining unit amendment, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' agreement was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.


IT IS THEREFORE ORDERED that the bargaining unit initially determined in PERB Case No. 5973 and amended in Case No. 6374 and the certification of the Chauffeurs, Teamsters & Helpers, Local Union No. 238, is amended to provide:

INCLUDED: All regular full-time and part-time Police Officers, including officers with the rank of Sergeant, Lead Dispatcher and Dispatchers in the City of Manchester Police Department.

EXCLUDED: Chief of Police, First Sergeants, Records Administrator, as well as all elected officials, confidential employees, other city departments and any others excluded by the Act.

AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

A petition for amendment of bargaining unit was duly filed under Section 13 of the Public Employment Relations Act [Act], Chapter 20, Code of Iowa (2001) and Rule 4 6 of the Public Employment Relations Board [Board or PERB], accompanied by a stipulation signed by the representatives of both parties. Said petition was tentatively approved by the Board and deletes the position of sergeant to the existing list of positions specifically excluded from the bargaining unit, and further adds the position of sergeant to the list of positions specifically included in the bargaining unit and finally, adds the position of First Sergeant to the list of positions specifically excluded from the bargaining unit, a Public Notice of Proposed Decision of Amendment of Bargaining Unit was posted in conformance with PERB Rules, and no objections were filed.

IT IS THEREFORE ORDERED that the bargaining unit previously determined in Case No 5973, and the certification of Chauffeurs, Teamsters & Helpers, Local Union #238, is amended to read as follows:

INCLUDED: All regular full time and part time police officers including sergeants, and dispatchers in the City of Manchester Police Department

EXCLUDED: Chief of Police, First Sergeants, Chief Dispatcher, confidential employees, all elected officials, other City departments and any others excluded by the Act
