Said Stipulation was tentatively approved by the Board; a Public Notice of Proposed Decision of Amendment of Bargaining Unit was posted in conformance with PERB Rules; and no objections were filed, therefore:



INCLUDED: All uniformed employees of the Fire Department of the City of Marshalltown to include Fire Fighters and Lieutenants.

EXCLUDED: Captains, Assistant Chief/Fire Marshal, Deputy Chief/Training Officer, and the Chief of the Marshalltown Fire Department.


AMENDMENT TO

ORDER OF CERTIFICATION

Now on this 8th day of October, 1975, the Board being advised that an election was conducted on May 22, 1975, pursuant to order of the Public Employment Relations Board and that Local Union #715, International Association of Fire Fighters, an employee organization, received an affirmative vote of a majority of employees in the bargaining unit, and the Board having further found that the aforesaid employee organization has fully complied with all regulations of the Public Employment Relations Act and the rules and regulations thereunder,

IT IS HEREBY ORDERED BY THE BOARD that Local Union #715, International Association of Fire Fighters should be and hereby is designated and certified by this Board to be the exclusive bargaining representative for the employees of City of Marshalltown a public employer, in the following bargaining unit:

INCLUDED: All uniformed employees of the Fire Department of Marshalltown, Iowa including Firefighters, Lieutenants, Captains, Fire Marshal and Training Officer.

EXCLUDED: Chief of Marshalltown Fire Department and all other persons excluded by Section 4 of the Act.
