Upon a petition for amendment of bargaining unit duly filed pursuant to Iowa Code section 20.13 and PERB rule 621-4.6(20), the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.





INCLUDED: All regular full-time and regular part-time employees of the City of Osceola Water Board and of the City of Osceola in the Streets, Parks, Water and Sewer Departments.

EXCLUDED: Mayor, elected officials, Administrator/Clerk, Sewer Department Superintendent, Parks & Recreation Director, Street Superintendent, Plant Superintendent and Distribution Superintendent, Supervisors, clerical employees, all other City employees, and all others excluded by Section 4 of the Act.
