AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

Upon a petition for amendment of bargaining unit duly filed pursuant to Iowa Code section 20.13 and PERB rule 621-4.6(20), the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.

IT IS THEREFORE ORDERED that the bargaining unit of employees of the City of Red Oak initially determined in PERB Case No. 2956 and amended in 6971, and the certification of Chauffeurs, Teamsters and Helpers, Local Union No. 238, are amended to provide:

INCLUDED: Detective/investigator, senior patrolman, master patrolman, patrolman, permanent reserve officers, and records employees.

EXCLUDED: Chief of Police, Assistant Chief of Police, lieutenant, sergeant, all elected officials and all others excluded by Iowa Code section 20.4.

AMENDMENT OF CERTIFICATION




