AMENDMENT OF CERTIFICATION





INCLUDED: All employees of the City of Shenandoah, Iowa, including Police, Fire, Water/Sewer, Street, Parks Departments, and Library.

EXCLUDED: All elected officials, supervisors, clerical employees, confidential employees, and others excluded by the Act.
