EXCLUDED Chief, Assistant Chief, Captains, Lieutenants, all civilian employees of the Department, all other city employees, and all those excluded by Section 4 of the Act

ADDENDUM TO MASTER AGREEMENT

The Association and the City hereby agree that all reference to Captains and Lieutenants as members of the Bargaining Unit shall be deleted from the Master Agreement existing by and between them effective July 1, 1982. Any provision of the Master Agreement to the contrary, notwithstanding.

Further, the parties hereby agree that the salaries for those holding the positions of Captains or Lieutenants within the Waterloo Police Department during fiscal year 1982-83 and 1983-84, shall be as follows:

Further, during the term of the current Master Agreement ending on the 30th day of June, 1984, the Lieutenants and Captains included within the force of the Waterloo Police Department would be entitled to each and every benefit provided for therein for members of the Bargaining Unit.

Further, the parties agree that during the period of the current Master Agreement, the City shall bear the responsibility of developing a management package for the Captains and Lieutenants within the Police Department which, upon the expiration of the proposed Master Agreement in June, 1984, would become the governing policy with respect to further benefits and salaries of persons occupying the positions of Captains and Lieutenants within the Department.
