ORDER OF CONTINUED CERTIFICATION

Following the filing of a valid representative decertification petition pursuant to Iowa Code section 20 15(6) and PERB rule, a decertification election was conducted herein under the direction and supervision of the Board. The Board, having subsequently reviewed the file and being fully advised in the premises, finds that a majority of the valid votes were cast against the decertification of Chauffeurs, Teamsters & Helpers, Local Union No 238, as the exclusive bargaining representative of the bargaining unit described below

No objections to the proposed decision having been filed as provided for in Iowa Code section 20 15(4) and PERB rule, the Board finds that an order of continued certification should be issued

IT IS THEREFORE ORDERED that Chauffeurs, Teamsters & Helpers, Local Union No 238, remains the exclusive bargaining

representative of the following bargaining unit originally determined in PERB Case No 4265 and amended in Case No 4912

INCLUDED All Bus Drivers, and Drivers of Special Education Routes using passenger cars, station wagons, and vans designed to carry not more than nine passengers driven by person holding a state approved bus drivers permit employed by the Central Lee Community School District

EXCLUDED Superintendent, Principals, Director of Transportation, Bus Mechanic, all other Central Lee employees that would drive a bus for purposes other than hauling students, all substitute bus drivers, and all other employees employed by the Central Lee Community School District and those excluded by Iowa Code section 20 4




IT IS HEREBY ORDERED that the bargaining unit previously determined in Case No. 4265 and the certification of 4265, is amended to read as follows:

EXCLUDED: Superintendent, Principals, Director of Transportation, Bus Mechanic, all other Central Lee employees that would drive a bus for purposes other than hauling students, all substitute bus drivers, and all other employees employed by the Central Lee Community School District and those excluded by Section 4 of the Act



EXCLUDED: Superintendent, Principals, Director of Transportation, Bus Mechanic, all other Central Lee Employees that would drive a bus for purposes other than hauling students, all substitute bus drivers, drivers of passenger cars, station wagons and vans designed to carry not more than nine person as passengers, unless driven by bus drivers holding a state approved bus drivers permit, and all other employees employed by the Central Lee Community School District and those excluded by Section 4 of the Act.
