IT IS THEREFORE ORDERED that the bargaining unit previously determined in Case No 5901, and the certification of AFSCME/Iowa Council 61, is amended to read as follows

INCLUDED All full-time and part time classified (non-certified) employees (head cook and head custodians) in the Creston Community School District

EXCLUDED All elected officials, certified employees, High School and Middle School principal's secretaries, central office personnel, classified employees covered by another bargaining unit and all others excluded by the ACT
