AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

Upon a petition for amendment of bargaining unit duly filed pursuant to Iowa Code section 20 15 and PERB rule 621-4 6(20), the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.

IT IS THEREFORE ordered that the bargaining unit of employees of the East Buchanan Community School District initially determined in PERB Case No 358 and amended in Case No 4236, and the certification of the East Buchanan Education Association, is amended to read as follows:

INCLUDED All full-time and regular part-time teachers, librarians, guidance counselors, school nurses, principals' secretaries, teacher aides/associates, food service workers and custodians

EXCLUDED Superintendent of Schools, principals, board secretary, superintendent's secretary, Food Service Supervisor, Buildings and Grounds Supervisor, transportation employees, and all others excluded by Section 4 of the Act


IT IS HEREBY ORDERED that the bargaining unit previously determined in Case No. 358, and the certification of East Buchanan Education Association, is amended to read as follows:

EXCLUDED: Superintendents, principals, board secretary, superintendent's secretary and all others excluded by Section 4 of the Act.
