ORDER OF CERTIFICATION

NOW on this 5th day of August, 1976, the Board being advised that an election was conducted pursuant to Order of the Board, and that Fort Dodge Community School Custodial and Maintenance Club, an employee organization, received an affirmative vote of the majority of employees in the bargaining unit, and the Board having further found that the employee organization has fully complied with all regulations of the Act and the rules and regulations thereunder,

IT IS HEREBY ORDERED BY THE BOARD that Fort Dodge Community School Custodial and Maintenance Club, should be, and hereby is, designated and certified by this Board to be the exclusive bargaining representative for the employees of Fort Dodge Community School District, a public employer, in the following bargaining unit:

INCLUDED: All full-time employees of the Department of Transportation and Department of Buildings and Grounds of the Fort Dodge Community School District, including maintenance and custodian personnel. (unit 1)

EXCLUDED: Director and Assistant Director of Transportation, Director and Assistant Director of Buildings and Grounds, clerical staff of transportation department and buildings and grounds department, all other personnel in the Fort Dodge Community School District and all other persons excluded by Section 4 of the Act.
