AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

Upon a petition for amendment of bargaining unit duly filed pursuant to Iowa Code section 20.13 and PERB rule 621-4.6(20), the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.

IT IS THEREFORE ORDERED that the bargaining unit initially determined in PERB Case No. 454, and amended in Case No. 1167 and the amendment of certification of the Fort Dodge Education Association, is amended to provide:

INCLUDED: All full-time and part-time certificated teachers, nurses, teacher librarians, guidance counselors, Title I teachers.

EXCLUDED: Superintendent, principals, assistant principals, directors, coordinators, administrative assistants, teacher associates, substitute teachers, case managers, all non-licensed employees of the Fort Dodge Community School District, and all other persons excluded by Section 4 of the Public Employment Relations Act.

AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

Upon a petition for amendment of bargaining unit duly filed under Section 13 of the Public Employment Relations Act and Rule 4.6 of the Public Employment Relations Board's Rules and Regulations, the parties waived hearing and filed with the Public Employment Relations Board a stipulation of bargaining unit changing the job classifications of the previously determined bargaining unit.

Said stipulation having been tentatively approved by the Board and posted in conformance with the Board's Rules and Regulations, and no objections having been filed thereto, and the Board having no objections;

ORDER


IT IS HEREBY ORDERED that the bargaining unit previously determined in case number 454 and the certification of the Fort Dodge Education Association in that case be and hereby are amended to read as follows:

INCLUDED: All full-time certificated teachers, part-time certificated teachers teaching three (3) or more class periods per day, nurses, librarians/media personnel, guidance counselors, and Title I teachers not employed for parochial schools;

EXCLUDED: Superintendent, assistant superintendents, principals, assistant principals, directors, coordinators, administrative assistant, teacher associates,

substitute teachers, part-time teachers teaching less than three (3) class periods a day, Title VII personnel, all non-certified employees of the Fort Dodge Community School District, and all other persons excluded by Section 4 of the Public Employment Relations Act.

NOW on this 9th day of December 1975, the Board being advised that an election was conducted pursuant to Order of the Board, and that



INCLUDED: All full-time and certificated teachers, nurses, librarians/media personnel, guidance counselors, and Title I teachers not employed for parochial schools.

EXCLUDED: Superintendents, assistant superintendents, principals, assistant principals, directors, coordinators, teacher associates, substitute teachers, part-time teachers, administrative assistant, Title VII personnel, all non-certified employees of the Fort Dodge Community School District, and all other persons excluded by Section 4 of the Act.
