AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

Upon a petition for amendment of bargaining unit duly filed pursuant to Iowa Code section 20.13 and PERB rule 621-4.6(20), the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.

IT IS THEREFORE ORDERED that the bargaining unit of employees of the Southeast Polk Community School District initially determined in PERB Case No. 83 and amended in Case No. 2464, and the certification of the Southeast Polk Education Association, is amended to provide:


INCLUDED: Regularly contracted full-time and part-time certified employees, including classroom teachers, counselors, nurses, special education personnel, librarians and all other contracted certificated non-administrative personnel.

EXCLUDED: Superintendent, assistant superintendent, business manager, athletic director, assistant athletic director, principals, all non-certificated personnel, and all others excluded by Iowa Code section 20.4.

EXCLUDED: Superintendent, principals, assistant superintendent, director of elementary education, athletic director, director of secondary education, department heads, all non-certificated personnel, and other persons excluded by Section 4 of the Act.


