
AMENDMENT OF CERTIFICATION

EXCLUDED Secretary to the Superintendent, Secretary to Assistant Superintendent-Pupil Personnel Services, Secretaries to Assistant Superintendent-Personnel, Secretary to Assistant Superintendent-Curriculum and Instruction, Secretary to Director of Research, Evaluation and Development, Secretary to Director of Business Administration, Secretary to Director of School-Community Relations, Business Office Manager, Supervisor-Operator and Assistant of Word Processing Center, Secretary to Director of Building Administrators.
