AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

Upon a petition for amendment of bargaining unit duly filed pursuant to Iowa Code section 20.13 and PERB rule 621-4.6(20), the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.

IT IS THEREFORE ORDERED that the bargaining unit of employees of the Keystone Area Education Agency #1, initially determined in PERB Case No. 2864, and the certification of Keystone Education Support Staff/ISEA, are amended to provide:

INCLUDED: The following classified personnel positions with work assignments of at least twenty hours per week: Custodians, Media Clerks, Office Assistants, Paraprofessional I (Audiometrist, Instructional Aide, and Speech Language Pathology Assistant), Paraprofessional II (Certified Occupational Therapy Assistant and Educational Interpreter) and Van Drivers.

EXCLUDED: All other personnel not specifically included above and those excluded by Iowa Code section 20.4.
