AMENDMENT OF BARGAINING UNIT AND CERTIFICATION

Upon a petition for amendment of bargaining unit duly filed pursuant to Iowa Code section 20.15 and PERB rule 621-4.6(20), the parties filed with the Board a stipulation of bargaining unit as amended, which was tentatively approved by the Board. A public notice of the Board's proposed decision to amend the bargaining unit in accordance with the parties' stipulation was posted in conformance with PERB's rules, and no objections to the proposed decision were filed.

IT IS THEREFORE ordered that the bargaining unit initially determined in PERB Case No. 451 and amended in Case No. 1535, and the certification of the Professional Staff Organization of the Mississippi Bend Area Education Agency, is amended to provide:

INCLUDED: School psychologist, speech-language pathologist, school social worker, audiologist, educational consultant, educational consultant/preschool, consultant/hearing impaired, consultant/visually impaired, teacher/hearing impaired, teacher/early childhood special education, teacher/behavioral disorders, teacher/visually impaired, occupational therapist, physical therapist, work experience coordinator, transition specialist, quality learning consultant, middle school coordinators, program leader: curriculum, program leader: technology, program leader: staff development, program leader: parents as teachers, program leader: media.

EXCLUDED: Chief administrator, division directors, coordinators, head positions, executive secretaries, administrative secretaries.

EXCLUDED: Administrators, managerial employees, supervisors and all other employees excluded by Section 4 of Chapter 20 of the Code of Iowa and all other employees.

Now on this 30th day of October, 1975, the Board being advised that an election was conducted on October 17, 1975, pursuant to order of the Public Employment Relations Board and that Professional Staff Organization of the Area Education Agency IX an employee organization, received an affirmative vote of a majority of employees in the bargaining unit, and the Board having further found that the aforesaid employee organization has fully complied with all regulations of the Public Employment Relations Act and the rules and regulations thereunder,

IT IS HEREBY ORDERED BY THE BOARD that Professional Staff Organization of the Area Education Agency IX should be and hereby is designated and certified by this Board to be the exclusive bargaining representative for the employees of Area Education Agency IX a public employer, in the following bargaining unit:

INCLUDED All full-time and regular part-time professional employees: speech clinicians, hearing clinicians, social workers, psychologists, occupational therapists, physical therapists consultants, diagnostic programmers, and classroom teachers

EXCLUDED Area Education Agency Administrator, division directors, as directors, supervisors, co-ordinators, principal-consultant communication specialists, project specialists, systems representatives, head teachers, and all others excluded by Section 4 of the Act.
