INCLUDED: All regular full-time, Operator I, Operator II, Rodman, Mechanic Helper, Mechanic I, Mechanic II, Laborer, Engineering Aide I, and Engineering Aide II

EXCLUDED: County Engineer, Assistant County Engineer, Secretaries, Clerical, Landfill Employees, and any other persons excluded by Section 4 of the Act

EXCLUDED County Engineer, Assistant to County Engineer, Secretary, Bridge Foreman, Maintenance Foreman, and Shop Foreman
